

In Safe Hands...

IN ONE OF THE LARGEST PARKS IN NEW YORK CITY, WITH THOUSANDS OF VISITORS A DAY, HUDSON RIVER PARK'S PARKS ENFORCEMENT PATROL (PEP) FACES THE IMPORTANT CHALLENGE OF MAINTAINING THE SECURITY OF THE PARKLAND AND ITS GUESTS.

From reuniting children separated from their parents, to enforcing safe speed limits on the bike path, to controlling crowds at large park

events, Parks Enforcement Patrol officers make sure that your visit to the Park is a safe one.

Over forty Parks Enforcement Patrol officers guard the Park 24-hours a day. They also hold education programs, such as Bike Safety days, where officers register bicycles and inform bike-way users of the Park and City bike use rules and regulations. Hudson

River Park's officers also aided in the rescue efforts on September 11th, helping to evacuate workers from the Financial Center and students from Stuyvesant High School.

Parks Enforcement Patrol officers can make arrests and issue summonses for all types of offences. They have the authority to enforce not only the HRP Rules and Regula-

tions and the NYC Parks Rules and Regulations, but also the NYS Penal Law, NYC Public Health Law, the NYC Environmental Control Board Rules, and any Federal Laws relevant to Parks Property.

www.hudsonriverpark.org for the latest information on summer events.

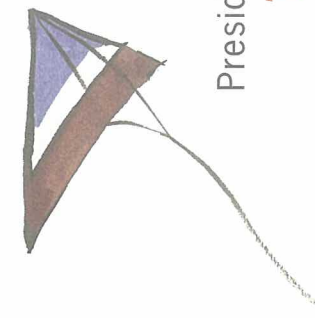
