MAINTENANCE & OPERATIONS: HUDSON RIVER PARK'S VIGILANT WORKFORCE

ENSURING THE SAFETY, BEAUTY AND INTEGRITY OF HUDSON RIVER PARK IS A MORE DETAILED AND COMPLICATED TASK THEN MANY REALIZE. In fact, most who are familiar with the park know of and utilize its facilities, but are unaware of the almost around the clock maintenance schedule kept by the Park's Department of Maintenance & Operations. It is the members of this department that keep the 5-mile park in working order.

It is the Department of Maintenance & Operations that keeps the bikeway/bladeway smooth and the lines and marks on the recreational fields fresh. The trees trimmed and the grass cut. The litter picked up and the trash removed. The benches sturdy and the gates swinging.

"WHEN I SEE ALL THE PEOPLE ROLLERBLADING, JOGGING OR USING ANY OF THE PARK'S FACILITIES, IT SHOWS THE WONDERFUL JOB THE STAFF OF THE DEPARTMENT OF MAINTENANCE & OPERATIONS HAS DONE," MORENO SAID.

Maintenance is only one aspect of the department's responsibilities and not all their assignments are confined to land. The

department also serves as an unofficial security force for the entire 550-acre park. Because they are always out and about making sure that the public spaces are clean and in good repair, they are frequently the first ones on hand if a park patron has an emergency.

In the waterways around the park, the department ensures the safety of boaters by placing navigation guides and buoys and standing by to assist should anything occur that couldn't be reached from landside.

As the construction project progresses and is eventually completed, the staff of the Department of Maintenance & Operations will have more responsibilities, more facilities to inspect and more repairs to make. Given what they have already accomplished and continue to achieve on a daily basis, many times going unrecognized, the staff of the Department of Maintenance & Operations is ready to meet the challenge and keep Hudson River Park in good working order for many years to come.

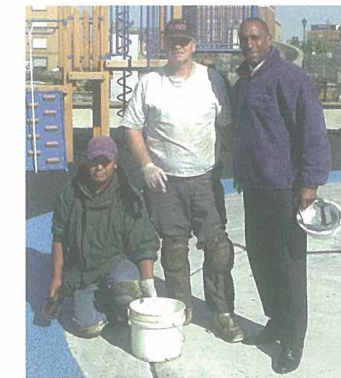

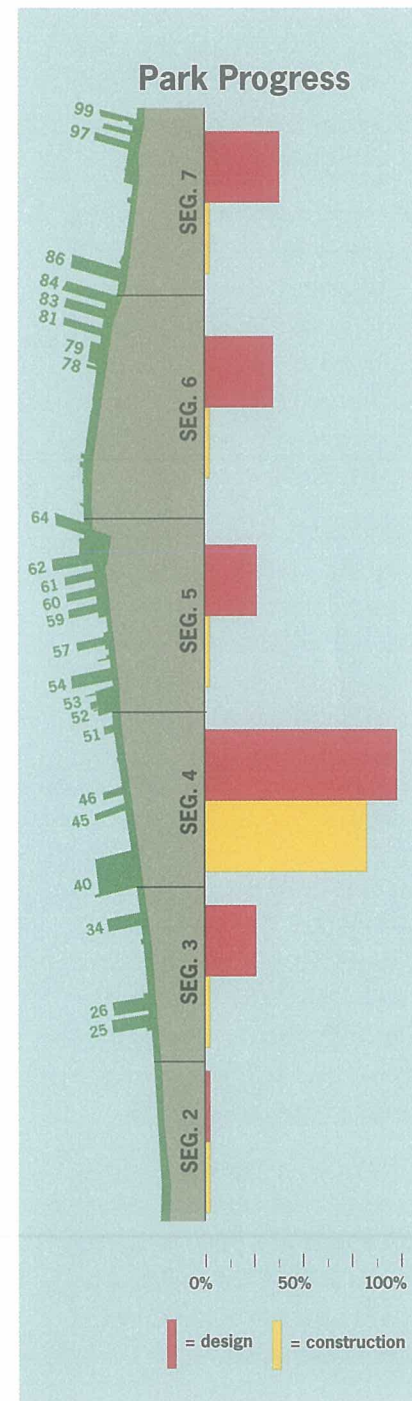
