

DESIGNERS SELECTED FOR SEGMENTS 2, 3 AND 5.

This summer the Trust selected design teams for the remaining park segments. Segments 2 and 3 will be designed by a team led by landscape architects Sasaki Associates, Inc. and marine engineers DMJM+Harris. Segment 2 (formerly Segments 1 and 2), runs from Battery Place along the Battery Park City boundary line to Harrison Street in Tribeca. Segment 3 begins at Harrison Street and goes to Pier 40. Community workshops to finalize the park program in this area will be scheduled as soon as the residents of Community Board 1 are safely back in their homes.

Segment 5 will be designed by a team led by landscape architects Michael Van Valkenburgh Associates. Their partners in designing Segment 5 are Beyer Blinder Belle, architects, Lynden Miller, public garden designer, and Mueser Rutledge, marine engineers. The team will make a presentation to the community on October 3rd at the

regularly scheduled meeting of Community Board 4. A design workshop with a group designated by the Board's waterfront committee will begin meeting later in October to finalize the park program for Segment 5. Segment 5 runs from Horatio Street in Greenwich Village to 25th Street in Chelsea.
