Description: Request for Proposals (RFP) - the Hudson River Park Trust (“Trust”), a public benefit corporation of the State of New York, is seeking a Landscape Architecture team to provide Landscape Architecture, Engineering, and Architecture Services for the Pier 97 Project, located in the portion of Hudson River Park between West 56th and West 59th Street. The team shall perform comprehensive professional design, construction document, and construction administration services in support of this project.

Professional firms, including small, minority, and women-owned firms interested in performing the services described above, are invited to submit their qualifications. Firms are encouraged to visit the site ahead of time to familiarize themselves with the project area. The RFP will not be provided until receipt of this check.

Evaluation criteria shall include but not be limited to: 1. Prime firm and proposed staff experience providing similar services as described in RFP; 2. Sub-consultant firm(s) and staff experience in providing services similar to the relevant tasks as described in the RFP; 3. Proposed fee and cost schedule; 4. Consultant team’s earliest committed project start date and time to complete the work as described in the RFP; 5. The respondent’s proposed plans for encouraging participation by minority and women-owned business enterprises in connection with the services to be provided.

Submissions will be evaluated to assess the proposer’s responsiveness, responsibility, relevant experience, adherence to M/WBE and SDVOB requirements as percentage of sub-contracting, and financial stability. HRPT is an equal opportunity contracting agency. Any resulting contracts will include provisions mandating compliance with Executive Law Article 15A and the regulations promulgated thereunder.
