REQUEST FOR QUALIFICATIONS FOR DESIGN AND RELATED CONSULTANT SERVICES FOR GANSEVOORT PENINSULA – CONTRACT NO. A4981

DESCRIPTION: Request for Qualifications (“**RFQ**”) – The Hudson River Park Trust (“**Trust**”), a public benefit corporation of the State of New York, is soliciting Statements of Qualifications (“**SOQs**”) from interested and qualified landscape architectural firms to provide design and related consultant services required to design and construct the Gansevoort Peninsula in the Hudson River Park (the “**Project**”). Located in Hudson River Park between Horatio Street and Little West 12th Street in the Meatpacking District of Manhattan, the 5.5 acre project site parallels Route 9A (West Street), between the western edge of the Route 9A bikeway and the U.S. pier head line.

Project Elements are anticipated to include: shoreline improvements, upland park finishes and improvements, vehicular circulation, bicycle and pedestrian access, and design of park buildings.

The firm/team shall be multi-disciplinary and shall provide landscape architectural and related engineering services including but not limited to site structural, geotechnical, site civil, topographic survey, site electrical, site lighting, site plumbing, roadway / traffic engineering, cost estimating, and other services and any other services as required for the completion of the project. Professional firms, including small, minority and women-owned firms interested in performing the services described above, are invited to submit their qualifications.

This RFQ invites Respondents to submit SOQs describing in detail their technical qualifications to perform the Contract Services. The issuance of this RFQ is the first step in a two-step procurement process. **ONLY THOSE FIRMS THAT RESPOND TO THIS RFQ AND ARE SHORT-LISTED BY THE EVALUATION COMMITTEE IN ACCORDANCE WITH THE REQUIREMENTS OF THIS RFQ WILL BE ISSUED A REQUEST FOR PROPOSALS (“RFP”) AND INVITED TO SUBMIT A PROPOSAL IN RESPONSE TO THE RFP. UP TO FIVE (5) FIRMS ARE EXPECTED TO BE SHORT-LISTED AS ELIGIBLE TO PARTICIPATE IN THE RFP STAGE OF THIS PROCUREMENT.**

Evaluation Criteria shall include the Respondent’s and proposed project team’s experience, technical qualifications, project understanding, financial qualifications and commitment to M/WBE participation and diversity.
