

## Pier 97 and Gansevoort Peninsula – CM Services RFP Project/Contract No. A5098 Questions & Answers September 16, 2019

- 1. Q: Is it possible to get a list of the potential primes? We are an MBE trying to team up with the primes.
  - A: The list of all entities that requested the RFP is attached.
- 2. Q: Are there construction cost estimates (just the total value of each project, not looking for a detailed breakdown) that can be made available for each of the 2 projects to be managed under this solicitation?
  - A: The current estimates are \$25M for Pier 97 and \$45M for Gansevoort Peninsula.
- 3. Q: Will this contract be awarded to multiple CM's?
  - A: No, there will be only one CM for both sites.
- 4. Q: Are there SDVOB goals for this contract?
  - A: Yes, SDVOB goal is 6%.
- 5. Q: Must M/WBE firms utilized to meet the 30% goal be State certified or can we use City certified firms?
  - A: Only New York State certified firms may be utilized to meet the contract 30% goal. Firms having only New York City certification, while eligible to perform subcontracting work, are NOT ELIGIBLE for credit toward the required contract goals.
- 6. Q: Do you want a superintendent for each project or one for both projects?
- A: The Consultant Team should have two superintendents one for Pier 97 and one for Gansevoort.
